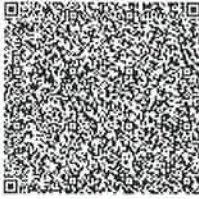

1. I am the General Secretary of the **KRISHNA CHARITABLE SOCIETY** and am duly aware and competent to swear the present affidavit.
2. That all moveable and immovable assets of the institution(s) shall be used only for the purpose of conducting academic activities, promotion of research, and related administrative requirements of the Institution Deemed to be University.
